We have a membership of 350+ skaters and operate 6 days per week out of the Rotary Place Arena and the Brian Orser Arena in Orillia, ON. The Orillia Figure Skating Club operates from September to May offering fall/winter and spring skating programs. These programs include PreCanSkate, CanSkate and StarSkate programs.

Our environment helps athletes lead healthy active lifestyles, while promoting teamwork, independence, goal setting, community leadership, and fun. Every season, we strive to provide our skaters with opportunities for recognition and achievement in their sport and daily lives. LAND ACKNOWLEDGMENT



SKATE CANADA PROGRAM STRUCTURE

The Orillia FSC follows Skate Canada's nationally developed program structure and therefore skaters and their families have a variety of choices and growth opportunities.

CanSkate is the flagship Skate Canada learn-to-skate program. Skaters have the flexibility to move from CanSkate into other avenues of skating and may participate in a combination of programs.

Skate Canada has developed three figure skating streams: StarSkate, Podium Pathway and Fit for Life. Once skaters have completed CanSkate they will continue to the StarSkate pathway. Skaters who want to pursue higher levels of figure skating may have the option to enter the Podium Pathway. Advancement in the Starskate pathway is based on successful completion of assessments and not on the skater's age or competition achievements. Skaters who enjoy skating as a recreational sport typically choose the StarSkate pathway. The StarSkate pathway offers a variety of local club competitions that use fun and awards to encourage skaters of all levels. Participating in skating opens doors and provides a multitude of opportunities to be involved with and connected to sport for life. Opportunities include continuing to skate at the Adult level, volunteering or working in sport related careers. Here are some of the many options.

ORILLIA FIGURE SKATING CLUB CANSKATE PROGRAMS

PreCanSkate

A 30 minute program for young skaters age 3 to 5. NO previous skating experience is required. Small group environment. Skaters are encouraged to stand and get up on their own, gain a sense of balance and control. Skaters are grouped by age and ability. Skaters who complete all PreCanSkate levels move onto CanSkate.

CanSkate


A 45 minute program for skaters age 6 and up **or** skaters who have completed PreCanSkate. NO previous skating experience is required. A complete series of balance, control and agility skills are taught. We track your child's progress through the badges and group them accordingly. Each sessions begins with a group warm up, followed by group instruction lead by a NCCP trained level coach and assisted by volunteer program assistants. Every lesson finishes with a group activity and cool down.

Canskate is Skate Canada's flagship learn to Skate program, developed by experts to teach the fundamentals of skating to beginners of all ages. PreCanSkate and CanSkate provides a solid background for all ice sports and is suitable for new skaters, as well as those with some experience. CanSkate is the feeder program for all other Skate Canada skating programs.

In our CanSkate Program, your skater will be in a program that focuses on fun, participation, and basic skill development. Your skater will earn, ribbons and badges as they learn fundamental skating skills.







The Orillia Figure Skating Club has achieved the 'CanSkate Excellence Exceeded Standard" in the Skate Ontario CanSkate Excellence Recognition program, designed to award Ontario Clubs/Skating schools that are implementing best practices in the delivery of their CanSkate programs. The Club achieved 'CanSkate Excellence Exceeded Standard' by delivering the CanSkate program in a way that ensures skaters are continuously moving on the ice, working through the program levels in a fun and safe manner, and keep skaters and families engaged and active. This award demonstrates the high quality of coaching being offered at the Orillia FSC.



Little Stars

The Orillia Figure Skating Club Little Stars program is designed to focus and improve our CanSkate skater's edges, turns, crosscuts, field moves, jumps and spins. Our coaching staff provide small group instruction for the entire 30 minutes. This program is by invitation only and is in addition on to the CanSkate program.

Development Team

The Development Team is by invitation only and is designed to focus and improve each skater's abilities. A team of professional coaches runs each 55-minute Development Team session. Skaters will be given group lessons in edges, turns, power, stroking, crosscuts, field moves, spins, jumps, footwork. Group instruction will be varied and will follow a structure that the coaching staff have agreed upon as a solid repertoire of skills for our skaters. Skaters are encouraged by being with their peers, motivated by performing for others or by seeing others performing skills beyond their current ability, and by having constant observation and instruction from coaches

Special Olympics

The Orillia Figure Skating Club is proud to partner with Special Olympics Ontario to offer skaters with intellectual disabilities the opportunity to train and compete in figure skating. Special Olympics athletes are fully integrated into OFSC's CanSkate and Star Skate programs. Coaching and support are customized to the skaters' unique needs and learning styles.

Special Olympics Ontario, along with the Orillia Figure Skating Club is dedicated to enriching the lives of Ontarians with an intellectual disability through sport. For many athletes, participating in Special Olympics is a path to healthy living, empowerment, acceptance and friendship. Special Olympics is dedicated to increasing physical fitness, confidence and other sport and life skills of our athletes; all in a positive and supportive environment.

Am I eligible for Orillia Figure Skating Club's Special Olympics programs?

In order to participate as an athlete with Special Olympics, you must:

- be eight years of age or older (does not apply to Learn to Skate Programs)
- have been diagnosed with an intellectual disability.

Head Coach Tracey Zwiers leads Special Olympics programming within the Orillia Figure Skating Club. Tracey has been a member of Special Olympics Team Canada participating at the Special Olympics World Winter Games in 2017 and 2022, as well as being the Head Coach for Team Ontario on several occasions. OFSC members have had great success representing Ontario and Canada at the National and World stages. The OFSC offers competitive and recreational skating opportunities to support Special Olympics athletes of varying abilities.

Markus has been coaching for 20 years. He is National (Level 3) Singles Certified and coaches in both Orillia and Bradford Figure Skating Clubs. Markus offers harness and jump lessons as a speciality freeskate coach.

Markus is a 7 time Finnish National Freeskate Champion. He has guest coached for Finland's Junior Team as well as in New Jersey and Hong Kong.

** Coaches are not permitted to solicit parents or skaters according to Skate Canada rules. Parents and coaches enter into a private agreement which may be ended at the discretion of the coach or parent. **

EQUIPMENT INFORMATION

All skaters in all programs are required to provide their own hockey or figure skates (lace-up recommended) and a CSA approved hockey helmet. - <u>NO bike or ski helmets will be permitted</u>. Skaters also need to provide their own warm clothing and gloves/mittens while they are on the ice. Helmets must be in good condition, not broken or missing pieces, and must fit the skater properly.

Helmets are required for PreCan & CanSkate All helmets must be CSA Approved



Helmets are required up to and including Stage 5

Hockey or Figure Skates are recommended.

SKATE CANADA HELMET POLICY

Helmet Use - Information for Clubs, Coaches and Parents

On July 1, 2011 Skate Canada implemented a Helmet Use policy. This policy was implemented as a proactive safety measure to help protect members in the early stages of the CanSkate program that are learning how to skate. Skate Canada believes it is an appropriate time to implement such a policy to help prevent future injuries to its members that are learning how to skate. In the development of the policy Skate Canada consulted various groups of individuals including parents, and the policy was approved by the Skate Canada Board of Directors earlier in 2011.

Skate Canada is proud of its CanSkate program, the best learn-to-skate program in Canada, and we will continue to develop policies and programming that create a better and safer learn-to-skate experience for our skaters. If you would like more information on helmet use and injury prevention we recommend you visit Parachute Canada.

Coaches, clubs or skating schools should not dictate that a skater should not wear a helmet.

- Skaters working on STAGE 5 and below, as well as all skaters in the PowerSkate program, MUST wear CSA approved hockey helmets.
- Skaters working on STAGE 6 or higher may choose to continue to wear a helmet at their discretion. The skater, parent/guardian have the final say as to whether or not the skater will or will not wear a helmet.
- Coaches are in charge of ensuring what a skater wears on the ice is safe. This applies to clothing, hair, skates etc.

How should the hockey helmet fit?

- A hockey helmet should fit snug to prevent any shifting and maximize protection. Make sure the chinstrap can be adjusted so it gently makes contact under the chin when fastened.
- For an adjustable helmet, open it to the largest setting and gradually begin to downsize the helmet until a comfortably snug fit is achieved. The helmet should rest on the head so that the rim is one finger width above the eyebrow and making contact with the top of your head.
- Although most helmets are lined with protective foam, some helmets will feel better than others. Try on different brands of helmets for fit and comfort.
- All CSA certified helmets have a sticker indicating their certification.

Why only hockey helmets?

• Hockey helmets are designed to help protect against head injuries occurring on ice, whether from a fall or collision. A bicycle helmet, for example, is designed to protect against head injuries should a fall occur while riding a bicycle. It is important to ensure that when a skater is on the ice, they are protected with equipment designed for their sport or activity.

Are face masks required as well?

 Face masks are not mandatory; however young skaters may benefit from the added protection.

Are used hockey helmets acceptable?

 Hockey helmets and face protectors sold in Canada must meet safety standards set by the Canadian Standards Association (CSA). If the CSA sticker is not present, throw the product away. Hockey helmets must have labelling with the date of manufacture and have a chin strap. CSA takes the position that the life span of a helmet is not easy to determine and so CSA does not give expiry dates for hockey helmets. CSA advocates that "consumers should exercise good judgement as to the suitability of a hockey helmet for play. Helmets that are cracked, have loose fitting or missing liner pieces, or that have been subjected to a severe blow should be replaced. For a hockey helmet to function effectively, it must be in very good working order and worn properly in accordance with the manufacturer's instructions."

Can a parent sign a waiver absolving the club from any liability and allow their child to participate without a helmet?

• No. The requirement to wear a helmet is a Skate Canada Policy and all clubs and members must abide by our policies. Therefore, in order to participate in the CanSkate program all skaters who have not achieved Stage 5 in the CanSkate program or who lack good balance and control must wear a CSA approved hockey helmet while on the ice.

Why has up to and including Stage 5 been selected as the benchmark for helmet use?

- Skaters who lack good control/balance when skating forward, backward and have difficulty stopping, as well as maneuvering around obstacles on the ice are at a higher risk of being unable to control a fall, regardless of their age.
- The CanSkate program has been developed to introduce basic skating skills to beginners in a safe and sequential manner. The learning progressions leading to and included in Stage 5 allow skaters to gain the necessary skills (balance, agility, and control) required to safely participate on the ice. While it may be likely that many Stage 5 skaters can skate reasonably well, ice surfaces can be very unpredictable and there is always a risk of falling, no matter what stage a skater is at. CanSkaters participate in a group environment with other skaters on the ice of different levels who may fall and cause other skaters to fall.

This is an additional cost for parents. Does Skate Canada provide any incentives or fee reductions for CanSkate members having to purchase a helmet?

 Most hockey helmets retail for approximately \$50. Many CSA approved hockey helmets are adjustable and could be used for many years of skating both within the club and recreationally outdoors during the winter months. Skate Canada does not currently offer incentives for parents.

I am a coach. What do I do if there is a skater on the ice that should be wearing a helmet, but is not?

- The helmet policy is not optional for clubs therefore should a skater who, according to our policy must wear a CSA approved hockey helmet, arrives at the rink and wishes to go on the ice without a helmet, he/she must be refused entry onto the ice surface.
- Coaches are aware of this new policy and coaches should not be put into a situation where
 a skater who must wear a CSA approved hockey helmet is on the ice without the proper
 helmet. If this happens, the coach should escort the child off the ice as he/she does not
 meet the Skate Canada helmet policy requirement to participate in that program. Coaches
 must ensure the safety of the skaters at all times therefore if a skater is on the ice without an
 approved hockey helmet, this is a safety concern that must be addressed.
 - A coach cannot be reprimanded for enforcing Skate Canada Rules and Policies within a club.
 - Coaches should encourage and positively reinforce the use of hockey helmets in the CanSkate program

What other tips could you provide regarding prevention of falls and head injury?

There are several ways to avoid head injury, in addition to wearing a helmet. The following are some basic guidelines:

- Use quality equipment skates with good support, proper fit, laced correctly and sharpened regularly help the skater maintain control on the ice therefore less chance of falling
- Dress appropriately no scarves, overly bulky snowsuits, or hair in the face as this may restrict movement, vision
- Warm up and cool down appropriately to avoid muscle strain and stress on the joints

- Use skill progressions to prepare for more difficult moves; coach must ensure that beginners are taught proper way to fall and get up
- Ensure coaches have valid first aid certification
- Group activity and practice areas must be well-supervised; during skill circuits and drills, skaters should be travelling in one direction to avoid collisions.
- Use pylons to mark any holes or cracks on the ice.
- Teaching aids must be safe and appropriate for the level of skater.
- Ensure sufficient space between skaters while executing skills.
- The number of skaters on the ice should be appropriate to the size and skill level of the skaters, the size of the ice surface and the nature of the activity.
- Enforce on-ice safety rules:
 - get up quickly after falling down
 - look in the direction of travel when skating backwards
 - no pushing, playing tag or other horse play
 - no gum, candy on the ice
 - keep rink doors closed during sessions
 - stops should be done a safe distance from the boards
 - keep first aid kit accessible

How can I identify a hockey helmet that is CSA approved? Where will the logo appear on the hockey helmet?

 The CSA approved logo will be found on the back of the hockey helmet affixed to the outer shell of the helmet. For more information about CSA standards visit <u>www.csainternational.org</u>

SKATER CODE OF ETHICS

Skating is a competitive sport requiring safe and courteous behaviour from all participants, both on and off the ice. Skaters need to be aware of one another to ensure the safety of everyone. Although skating is primarily an "individual" sport, all skaters must act as a team and exhibit team mentality while sharing the ice.

Each skater at the Orillia Figure Skating Club (OFSC) is responsible for being aware of and practicing the rules of etiquette and safety as noted in this document. This code of Ethics must be followed during all training sessions. All OFSC skaters are expected to act in accordance with these rules while representing our Club at exhibitions, competitions and other events.

General Ethics:

- Skaters must be courteous at all times to everyone, including their fellow skaters and parents, both on and off the ice in accordance with the <u>Skate Canada Code of Ethics</u> and the <u>City of Orillia Respect + Policy</u>
- 2. A Board Member or Coach has the authority to remove any skater from the ice for non-compliance of this code or non-payment of fees.
- 3. Coaches are not to be disturbed during lessons or in the Coaches' Area of the OFSC Office.
- 4. All Skaters must have a coach from the Bronze Level upwards.
- 5. Skaters may go to another session for a private lesson with a coach. The skater is to remain on the ice only for the time of the lesson. These lessons are limited to a maximum ½ hour, 3 times per month or the guest fee will apply. No group lessons are permitted off session, except dance or freeskate pairs. Skaters may skate up or down one session only, with approval only.
- Guest fees must be paid before skating. Guest fees are payable to a Board Member or your coach. Please notify your coach of your intention to guest skate. Guest Skating is limited to 3 times.
- 7. Money and valuables should not be left unattended. OFSC can bear no responsibility for lost or stolen items.
- 8. Skaters are encouraged to make an effort to support their fellow skaters during regular sessions and competitions/events.
- 9. Concerns/Complaints will be reviewed only if submitted in writing to the Board and will be reviewed by the OFSC Board in "Committee of the Whole" (closed session).

Conduct:

- 1. Skaters may not enter the ice surface until the Zamboni doors have closed and a coach must be on the ice.
- 2. Food, drink and gum are not permitted on the ice. Water bottles must be left at the boards. No glassware is permitted.
- 3. Skaters are expected to be skating <u>at all times</u> when on the ice. Skaters must get up promptly after a fall in order to keep pathways clear for other skaters.
- 4. Attention must be paid to the position of other skaters and coaches while skating to ensure the safety of all.
- 5. Foul language, yelling, abusive or aggressive behaviour, including kicking or picking holes in the ice, and the intentional making of "snow" is prohibited.

- 6. Pushing, tripping, horseplay, tag, racing or intentional interference with other skaters is not permitted on the ice.
- Proper attire must be worn by all skaters on all sessions (non-baggy athletic pants or leggings, tights/skating dresses or skirts, skating pants). <u>NO shorts or hoodies</u> allowed during on-ice sessions. Long hair should be tied back.
- 8. All Skaters who have not passed Stage 5 must wear a CSA approved helmet. There are **no** exceptions.
- 9. Skaters must follow the session schedule i.e. free skate only during free skate time, dance only during dance time, etc. unless in a lesson with their coach.
- 10. All skaters, including guest skaters, must skate on the session for which they are qualified.
- 11. All skaters are to participate in group stroking sessions unless receiving a private lesson.
- 12. Skaters should not leave the ice surface during a session unless absolutely necessary. It is good practice to obtain a coach's permission before leaving the ice.
- 13. Skaters must clear the ice promptly at the end of the session.
- 14. All out of town and guest, skaters must abide by the OFSC's Code of Ethics.
- 15. Skaters must conduct themselves professionally during all interactions in and surrounding Skate Canada activities.
- 16. Skaters will not participate in any form of bullying, harassment, discrimination, physical or verbal abuse, neglect, intimidation, or exploitation.
- 17. Skaters will not use technology or social media to disrespect or exploit others.

PARENT CODE OF ETHICS

The Orillia Figure Skating Club (OFSC) is committed to ensuring that all skaters have the opportunity to participate in a safe and welcoming environment that is encouraging and promotes their overall development. Parents have an enormous influence on skaters' experiences in the sport. The quality of a skater's experience is determined by their relationships with parents and the manner in which parents conduct themselves in the OFSC environment.

In this code "parents" shall refer to "parents and guardians". This code applies to all parents who are members of the OFSC or have children who are members of the OFSC. Parents shall always abide by this code while volunteering, attending or participating in any OFSC event, competition or sessions. All parents are expected to conduct themselves in a responsible manner consistent with the values of fair play, integrity, open communication and mutual respect.

Parents shall <u>always</u> model positive, responsible behavior and communicate with their child that they expect them to do the same. Parents will assume the major responsibility for their child's on-ice conduct and attitude. Parents shall always treat all individuals and property with dignity, courtesy and respect, including but not limited to skaters, coaches, officials, volunteers, other parents, members of the Board and all other individuals that are part of the club, Section or Skate Canada.

General Ethics:

- 1. Parents/Guardians must be courteous at all times to everyone, including skaters, their fellow parents and members of the Board in accordance with the <u>Skate Canada</u> <u>Code of Ethics</u> and the <u>City of Orillia Respect + Policy</u>
- 2. For insurance reasons, Parents/Guardians are <u>not</u> permitted on the ice surface.
- 3. Parents, Guardians or designate should remain in the arena for the entire session.
- 4. Coaches are <u>not</u> to be disturbed during lessons or in the Coaches' Area of the OFSC Office.
- 5. Parents/Guardians shall refrain from any behaviour or comments which are profane, insulting, harassing, sexist, racist, abusive, disrespectful or otherwise offensive without hostility or violence.
- 6. Parents/Guardians shall emphasize the importance of values like sportsmanship, respect, cooperation, competition and teamwork to their child, offering praise for competing fairly, participation and skill development.
- 7. Parents/Guardians shall set high, but reasonable expectations for their child's participation in skating focusing on development and enjoyment for the child.
- 8. Parents/Guardians shall instill confidence in their child's ability and skill development, always avoiding comparisons with other skaters.
- 9. Parents/Guardians shall celebrate the acquisition of skills and goals achieved by their child.
- 10. Parents/Guardians, along with the professional coach and the athlete, shall be considered members of a team whose main concern is the child's overall progress and development.
- 11. Parents/Guardians shall respect that the professional coach is responsible and empowered for the on-ice and off-ice development of the athlete. A parent/guardian's role shall be to take a healthy interest in their child's progress and development and be responsible for the child's nutrition, rest, adherence to off-ice

training regimen set by the coach or other fitness professional, overall health, lifebalance, and provide moral and emotional support.

- 12. Parents/Guardians shall ensure their child wears proper skating clothing and equipment.
- 13. Parents/Guardians shall openly support and uphold this code of ethics policy and take action and steps to ensure other parents follow and uphold this code of ethics policy.
- 14. Parents/Guardians shall adhere to the policies, procedures, rules, standards, and ethics of the OFSC and Skate Canada at all times.
- 15. Parents/Guardians will not use technology or social media to disrespect or exploit others.
- 16. Concerns/Complaints will be reviewed only if submitted in writing to the Board and will be reviewed by the OFSC Board in "Committee of the Whole" (closed session).

Disciplinary Action:

The OFSC Board will only commence Disciplinary Action when a written letter of complaint is forwarded to the Board. This letter will be reviewed by the board in "Committee of the Whole"

Upon receiving a written letter of complaint outlining a violation of the Code of Ethics, the OFSC Board will proceed with the following disciplinary action: *1st Offence*: Letter from the OFSC Board will be addressed to the Parent/Guardian outlining the nature of the violation.

2nd Offence: Suspension of the Parent/Guardian from all Club programs without compensation for 1 month. This includes all OFSC competitions, test days and mandatory club commitments. The Parent/Guardian will be responsible for finding a replacement for any Club commitment that falls within the suspension period.

3rd **Offence:** Suspension of the Parent/Guardian from all Club programs without compensation for 6 months. This includes OFSC all competitions, test days and mandatory club commitments. The Parent/Guardian will be responsible for finding a replacement for any Club commitment that falls within the suspension period.

4th Offence: Suspension for both the Skater and the Parent/Guardian from all Club programs without compensation for 1 year. This includes all OFSC competitions, test days and mandatory club commitments. Any outstanding account balances or fees for unfulfilled Club commitments that will be added to your account and must be paid in full within 30 days of the start of the suspension period.

In the case of a <u>serious</u> breach of ethics, the Parent/Guardian may be <u>immediately</u> <u>suspended</u> at the Board's discretion. In cases of suspension or expulsion, no refund of any kind will be granted.

The OFSC Board may, at their discretion, choose to file a complaint directly with the City of Orillia as per the terms of the Respect which could result in suspension from attending any sport related activities at facilities under the management of the City of Orillia.

Policy Statement

Orillia Figure Skating Club (OFSC) is a membership-based organization recognized by Skate Ontario, the governing body for the Orillia Figure Skating Club and by Skate Canada, which is the governing body of Skate Ontario.

The purpose of this policy is to contribute to the growth and development of skating for our community in a safe sporting environment by providing our OFSC members with billing and payment information and procedures for payments, refunds and credits.

This Policy strives to provide increased accountability to both parties and provide a mechanism for transparency, identification of governance issues and an enhanced commitment to safe sport.

Scope

This Policy applies to all registered members of the Orillia Figure Skating Club.

General

Prices: All prices are in Canadian currency and are inclusive of any applicable taxes.

eTransfer Payments: will be accepted by sending payments to <u>ofsctreasurer@gmail.com</u> *This is the only email address set up to receive payments*

Online Credit Card Payments: The following credit cards will be accepted by the Orillia FSC and all credit card transactions will be subject to a maximum 2.8% service processing administration fee.



**In person payments by cash or cheque are not available.

Program Payments

PreCanSkate, CanSkate & Other Non-StarSkate Programs:

Payments can be made in full or in monthly installments (on the 30th) of the 2023-2024 season and the payment method will be established (credit card or etransfer) at the time of registration. Skaters will <u>not</u> be permitted on the ice until the first installment payment is made in full. The skater's place in the program cannot be guaranteed if payment is not received in the required timeline. The last payment of this season will be on January 24, 2024.

StarSkate & Enhancement:

Payment will be in full or in monthly installments for the duration of 2023-2024 season; payments are due at regular intervals each month (on the 8th). Skaters will not be permitted onto the ice until the first payment is made. The last payment for this season will be on February 8th, 2024.

Requests for Special Payment Plans:

Special payment plan requests must be submitted in writing to <u>president@orilliafigureskatingclub.com</u> and will be reviewed by the Board for approval. If a skater is eligible for any type of sponsorship like JumpStart, please contact the Orillia FSC President at the above email.

Registration Requirements

PreCanSkate, CanSkate & Other Non-StarSkate Programs:

Skaters may select one (1) or two (2) days out of the three (3) day sessions offered (Monday, Wednesday, Friday).

StarSkate:

Skaters must register for a minimum of two (2) skating sessions per week.

Enhancement:

Enhancement is only available for StarSkaters and is by invitation only. Skaters must be registered for three (3) skating sessions per week (full time membership) in order to be in the enhancement program.

Development Team:

Development Team is only available by invitation only with a focus on skaters on badge 5 & 6 as well as StarSkaters working at the Star 1-5 level wanting more ice to help develop their skills.

Little Stars:

Little Stars is only available by invitation only with a focus on skaters in our early CanSkate program wanting more ice to help develop their skills and showing a love of the sport.

Fees Include

PreCanSkate, CanSkate & Other Non-StarSkate Programs:

- Club Group Coaching Fees
- Ice Expenditures
- Insurance

StarSkate:

- Club Group Time
 - Bronze Stroking, Skills, Dance, Synchro and Artistic
 - Silver Stroking, Synchro and Artistic
 - Gold Stroking
- Ice Expenditures
- Insurance

*Individual coaching fees are invoiced and paid separately for all StarSkaters.

All Skating Programs

Skate Ontario Lottery Tickets:

PreCanskaters, CanSkaters and StarSkaters will receive a booklet of tickets to sell as part of the OFSC's fundraising efforts with Skate Ontario. The cost of these tickets has been added to your registration fee. There are twenty (20) tickets in each booklet for a total of \$40.00. Sell each ticket at \$2.00 each and you keep the money. All ticket stubs will be due back before the Christmas break.

If you are part of the Enhancement Team, you will receive an additional booklet. The cost of these tickets has been added to your enhancement registration fee.

Note: The member, who wins the free fall/winter membership at the annual AGM, is not eligible to receive a booklet of tickets. (They can however purchase a booklet for \$40.00)

Skate Canada Membership:

A Skate Canada membership is mandatory for all skaters. Regardless of how many or which skating program a skater is registered for, this one-time annual fee must be paid prior to the start of the skater's first skating day of the season. Skaters will not be permitted onto the ice until payment is made in full.

The Skate Canada membership season is from September 1st to August 31st of the following year. The fee is \$60.00 for both children and adults which includes the OFSC administration fee. All Skate Canada fees are final and are not subject to refund or credit. *All dates and prices are subject to change*

Program Changes:

Any changes to a skater's category (eg. moving up from CanSkate to StarSkate) must be approved by the Orillia FSC Board and is subject to a prorated fee increase.

NSF Payments:

The OFSC will charge an administration fee of \$35.00 for each NSF cheque received.

Overdue Payments:

Each overdue payment is subject to an eighteen percent (18%) interest rate per annum, calculated on the daily outstanding balance and compounded monthly from its due date, both before and after demand, default and judgment, until paid.

Skaters will have 10 days to pay their overdue payment. If payment is not made, the skater will not be able to skate on their session until payment is received or a payment plan has been established with the OFSC President. For the final payment of the season, there will be no exceptions for the last payment. If payment is not received on the day indicated upon registration, the skater will not be able to participate in Carnival.

Skaters with overdue accounts will <u>not</u> be allowed to register for any other programs until the balance is paid in full. Skaters may be prohibited from participating in any Club events, Club competitions and Testing until the balance is paid in full.

Refunds and Credits

Withdrawal from a Skating Session Before the First Day of Skating:

Skaters who wish to withdraw from skating for any non-medical or non-injury related reason may receive a refund provided they withdraw before the start of the first skating session. These cases will be charged a \$50.00 administrative fee.

Withdrawal from a Skating Session Once a Skating Session has Started:

Skaters who wish to withdraw from skating for any non-medical or non-injury related reason may receive a refund. The Skate Canada membership and OFSC administration fee of \$50.00 is non-refundable regardless of which skating program a skater is being withdrawn from.

PreCanSkate, CanSkate & Other Non-StarSkate Programs:

- Withdrawal from any two day program will be charged an additional \$75.00 administration fee.
- No refunds will be processed after the 2nd scheduled class of the session without a medical certificate.

StarSkate & Enhancement:

- No refunds will be processed after November 15th for the Fall/Winter session or April 15th for the spring session without a medical certificate
- If eligible for a refund, it will be prorated based on the sessions skated.

Withdrawal from All OFSC Skating Sessions Due to Injury/Medical Reasons:

Skaters who are unable to skate due to an injury or medical reason may be given a credit towards a future season. The Club may request an official Doctor's Certificate from the skater requesting the credit. The credit may be pro-rated depending on how much of the season the skater has completed.

Any refunds and credits that are required due to any other circumstances will be determined at the discretion of the OFSC Board. All requests for refunds must be submitted in writing to the OFSC's President at president@orilliafigureskatingclub.com and will be reviewed by the Board for approval.

If a refund is granted, the method of refund will be determined by the OFSC. If a credit is granted, it will be processed against the skater's account that may be applied to an invoice for future skating or test tickets.

No refunds or credits are provided for missed sessions. Make-up ice for hours missed on a skater's scheduled day will <u>not</u> be granted. The Club is <u>not</u> obligated to refund registration fees for unforeseen ice closures due to special events/circumstances, snow days or equipment/mechanical breakdown beyond our control.

Credits:

Credits on Uplifter will expire 2 years after the finish of that fiscal year end.
